Use on exposed aggregate, concrete, terrazzo, and Chattahoochee. It helps prevent staining and soil penetration as well as brightening the substrate while making the surface tougher and more durable.

# STORAGE/SHELF LIFE

When stored in the original, tightly closed container, preventing the accumulation of water, dirt or other contaminants, the shelf life is two years from the date of purchase. Store in cool ventilated place. Protect material from direct sunlight.

### **SURFACE PREPARATION**

For use as a sealer: Before applying Super Stone® Floriginal Sealer, make sure all contaminants and bond-inhibiting materials are removed from the surface. Use Super Stone® Cleaner/ Degreaser to remove dirt, oil, and other petroleum based contaminants. Use Super Stone® Strip It Off to remove old acrylics, epoxies, and polyurethanes. Failure to remove contaminants will result in adhesion loss, reduced durability, or peeling. After cleaning, the surface must be allowed to dry completely or moisture may become trapped beneath the sealer resulting in a milky haze. Concrete must be fully cured.

#### **APPLICATION**

For use as a sealer: Super Stone® Floriginal Sealer may be applied with a brush, a ¼"-¾" nap roller, or a sprayer resistant to solvents. For best results, apply Super Stone® Floriginal Concrete Sealer in a thin, even coat when surface and ambient temperatures are above 50° F (10° C). The sealer may be thinned with Super Stone® Solvent (xylene). Let the first coat dry for 2-4 hours depending on humidity and repeat the procedure until desired results are achieved. Two thin coats are

recommended. Do not allow the product to puddle or collect in joints. Caution should be taken on non-textured surfaces as the end result can produce a surface that is slippery. Blending Super Stone® Super Grip® in the final coat of sealer gives the surface a Coefficient of Friction of 0.7 according to ASTM D 2047-93. Clean tools with Super Stone® Solvent (xylene).

**For use as a curing agent:** Super Stone® Floriginal Sealer may be applied in an even thin coat with a brush, a ¼"-¾" nap roller, or a sprayer resistant to solvents. New concrete must be hardened and the surface water and sheen have disappeared, usually about 4-6 hours after pouring. In hot weather the application time may be reduced to 2 to 3 hours after pouring. Surface and ambient temperatures must be above 50° F (10° C). Two thin coats are recommended. Do not allow the product to puddle especially with colored concrete. Cure-n-Seal reduces the need for wet curing in warm, dry, windy weather, improves strength, wear resistance and durability, while reducing shrinkage.

## **LIMITATIONS**

Super Stone® Floriginal Sealer should not be used in areas subject to:

- Water Submersion
- Significant Chemical Exposure
- Concentrated Abrasion/Scratching
- Metal Wheel Traffic
- Roadways

or as a waterproofing material or below-grade surfaces such as:

- Swimming Pools
- Concrete Ponds

#### **Shelf-Life 2 Years**

When stored in the original, tightly closed container, preventing the accumulation of water, dirt or other contaminants, the shelf life is two years from the date of purchase. Store in cool ventilated place. Protect material from direct sunlight.

Make sure that a test for compatibility is performed when sealing surfaces that have been treated with a curing membrane or sealer other than Super Stone® Floriginal Sealer. Due to the degree of varying surfaces, application of Super Stone® Floriginal Sealer is at the installer's discretion.
